SUBJECT: Off-Limits Establishments

1. These establishments/areas are declared off-limits to military personnel. If in any case the name or owner has changed, the address shall remain off-limits.

b. Areas.

(1) All bodies and streams of water on FT Campbell are off-limits for unauthorized water sports and activities.

(2) All rock quarries, both active and abandoned, within Kentucky and Tennessee are off-limits for all purposes. The only exceptions to this prohibition are:

(a) The Cerulean Spring Quarry, Cadiz, Kentucky, may be used for scuba diving only during operating hours.

(b) Martha's Quarry, located east of Lebanon, Tennessee may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.


(c) Cowan Quarry, located south of Cowan, Tennessee, and may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.

(d) Hopkinsville Diving Quarry, located off exit 9, adjacent Pennyryle Parkway, and 680. Non-diving recreational use is not permitted.

3. This off-limits list supersedes the Off-Limits Establishments memorandum dated October 21st, 2016.
